- **Description of content:** This draft Regulation introduces an authorisation procedure for mechanical recycling process producing recycled plastics to be used in plastic food contact materials and articles and amends the Regulation on good manufacturing practices with a specific Annex on GMP for recycling process to produce recycled plastics for food contact. As soon as the guidelines mentioned in Article 5.2 are available for comments, they will be notified according to the SPS Agreement.
- 7. Objective and rationale, including the nature of urgent problems where applicable: To facilitate trade by introducing harmonised rules for recycled plastic for use in contact with food in the EU, whilst ensuring consumer safety.
