Description of content:</b> This draft Commission Regulation concerns the authorisation of one health claim made on foods, other than those referring to the reduction of disease risk and to children's development and health in accordance with Articles 18(4) and 19 of Regulation (EC) No 1924/2006 of the European Parliament and of the Council of 20 December 2006 on Nutrition and Health Claims Made on Foods.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> The proposed measure is a Commission Regulation authorising a health claim made on foods and amending Commission Regulation (EU) No 432/2012, as referred to above under point 6 that has been assessed by the European Food Safety Authority (EFSA), and which comply with the conditions set out Regulation (EC) No 1924/2006.
