This standard is concerned with identifying the specific requirements of energy efficiency for dishwashers in methods of measuring and calculating energy efficiency, which aims to reduce the consumption of electric power, through some procedures to measure and calculate energy consumption and set a maximum limit to the values of energy consumption.
