Fertilizers which are traded in domestic market both originated domestically and imported shall meet the requirements SNI fertilizers.</p> <p>These IS SNS fertilizers standards specify for definition, quality requirements, sampling, test method, marking requirements, and packaging (these standards available in Indonesian language).</p>
