<b>5. Title, number of pages and language(s) of the notified document:</b> Draft Circular Regulating Formaldehyde Contents and Aromatic Amines Contents Which are Released from Azo Colourants in Textile Products (44 pages, in Vietnamese)
<b>6. Description of content:</b> This Circular will replace Circular No. 32/TT-BCT dated 5 November 2009 of the Ministry of Industry and Trade Temporary regulation on permitted limits of contents of formaldehyde and contents of aromatic amines which are released from azo dyes in reductive conditions in textile products.  This draft Circular specifies requirements on permitted limit of formaldehyde and aromatic amines contents in textile products, sampling methods, test methods as well as relevant quality management requirements.  This draft Circular applies to organizations and individuals who manufacture, import, distribute and sale textile products; and regulatory agencies operating in the fields of testing, inspection, certification and quality management of textile products.
